Last year was a milestone at Next Generation Foundation (NGF). With your generous support we were able to achieve our goals in all of our projects and general operations. We extend our sincere gratitude for your support. We have a higher goal this year and with your generosity we could easily achieve it. Your donation this year would go a long way in improving many orphans and underprivileged children's future.

This year too we are focused on our three major projects; NIRC (National Integrity and Responsibility Complex), Dharma Yuga Project, and THRIVE Project.

**NIRC Project** is one of the major projects NGF had undertaken in India to provide the best residential education for orphan and underprivileged children. The school construction has already started and we need your support to complete building the school and residential quarters for the first batch of children. NIRC is located in **Devrukh, Maharashtra**.

**Dharma Yuga Project** is NGF's self-sustaining program of "Kids Supporting Kids" in cities across several states in India. The seed money needed to launch one of these projects in a city in India that would result in the support of 1000 children is around \$8000 for the first year. A pilot project is being done in **Indore, Madhya Pradesh**.

**THRIVE Project** (THRIVE - To Help Rural Indian Villages Emerge) current focus is in Orissa; one of the most under-developed and impoverished states within India. Its rural communities have little or no chance of economic proliferation. We provide access to necessities such as clean water, food, and basic medical services. We are currently active in villages located 9 km from **Khandapara, Orissa**.

We are also launching new projects in our upcoming Chapters in **Tamilnadu** and **Andhra Pradesh**.

**I would like you to consider signing up for a monthly donation. It can be anywhere from \$15 or \$25 per month.** We will send you quarterly updates on the progress made in our projects. All the members of NGF in USA are volunteers, so, almost everything on a dollar donated goes towards our projects and their beneficiaries except for very minimal operational expenses.
